SECTION 9: FINANCIAL /SCHOOL FEE TERMS AND CONDITIONS

1. ACCEPTANCE OF LIABILITY

- 1.1 The person responsible for the account (hereafter the Account Holder) as set out in the standard Application for Admission (hereafter the Application) herewith assumes liability for the account, alternatively bind him/herself as co-debtor and surety for payment of all fees to Global Academy of Education NPC (hereafter GAE).
- 1.2 The legal guardian, as described in the Application, bind him/herself as surety and co-debtor for the payment of all legal fees by the Account Holder of any other payment that may arise from this Agreement.

2. TERM OF PAYMENT

- 2.1 It is recorded that fees are determined during the 4th term and that the Account Holder is informed of the results via a general financial parents meeting.
- 2.2 The Account Holder shall shall be informed via WhatsApp of their outstanding account balances at the end of every month.
- 2.3 All fees are payable **monthly in advance** by means of direct deposit or EFT, on or before the 7th of each calendar month or termly by the second week of the term or annually in advance by 28 February.
- 2.4 GAE reserves the right to charge 5% on all accounts that are in arrears by 30 days longer.
- 2.5 In the event where existing account is / has not been managed in the proper manner, no further applications will be considered for the follow year.

3. BREACH OF CONTRACT

In the event where the undersigned surety, Account Holder or legal guardian commits a breach of contract of any of the terms of this Agreement, GAE may in it sole discretion:

- 3.1 Refuse the learner entry to the School's premises until the breach has been remedied; or
- 3.2 Claim damages from the Account Holder and / or the surety and legal guardian; or
- 3.3 Take whatever legal steps may be necessary.

4. General

This Agreement constitutes the whole Agreement between the parties to the subject matter hereof. No amendments of consensual cancellation of this Agreement or any provision of terms thereof or any Agreement, bill of exchange or other documents issued or executed pursuant to or in terms of the Agreement and no settlement of any disputes arising under this Agreement and no extension of time, waiver or relaxation or suspension of any of the above provisions or terms of this Agreement or any Agreement, bill of exchange or other documents issued pursuant to or in term of this Agreement shall be binding unless recorded in a written document signed by the parties. Any such extension, waiver or relaxation or suspension which is so given or made shall be strictly construed as relating strictly t the matter in respect whereof it was made of given.

5. Jurisdiction

This Agreement is subject to South African law.



6. Credit Information

The Account Holder, surety or legal guardian herby consents to the disclosure and exchange of personal financial information to a credit bureau or financial institution in accordance with the national Credit Act.

7 Domicilium

The parties choose as their domicilium citandi et executandi the addresses set out in the Application.

8. Legal Fees

In the event where GAE takes legal action against the Account Holder, he/she will be liable for all legal fees on an attorney client scale, collection costs and commission, interest and tracing fees.

9. Cancellation

- 9.1 The Account Holder undertakes to give 30 (thirty) calendar days written notice of termination of the enrolment of a learner, failing which the liability for the full amount of the following term's fees shall be owing.
- 9.2 GAE shall be entitled to terminate enrolment of any learner under the following circumstances:
- 9.2.1 Summarily, and with immediate effect, if the learner is guilty of any offence which, in the sole opinion of the School, renders his/her continued enrolment at the School impossible, in which the event the Account Holder, after deduction of all amount otherwise owing to the School, will be refunded a pro-rata proportion of any fees already paid in advance in respect of such learner.
